

Corrigendum - Clarification regarding Pre-bid queries on SELECTION OF VENDOR/AGENCY FOR IMPLEMENTATION OF CAPACITY BUILDING WORKSHOPS UNDER RAMP held on 13th October 2025

1	Letter of Invitation 4.All bids shall be submitted exclusively through the Odisha Government e-procurement portal. 8.Instruction to Bidders 1. Tender submissions must be made exclusively through the Odisha e-procurement portal.	<u>Clause No.:8, Instruction to Bidders, P2:</u> Both the Technical and Financial Bids must be submitted in the prescribed formats as specified in the RFP. Hard copies of the bids are to be submitted at IED(O). The Technical bid should be placed in Envelope 1. and the Financial Bid must be placed in Envelope 2. Both envelopes must be placed in one outer envelope, which should be clearly superscribed with "Tender for Selection of Bidder/Vendor for carrying out different activities under RAMP Scheme" and to be dropped physically in the sealed tender box placed at the office of IED(O), Mancheswar, Plot No.:123, Sector A, Zone A, M.I.E, Bhubaneswar, Odisha. Instruction to Bidders: A refundable EMD of ₹1,00,000 and a non-refundable tender fee of ₹5,000 must be paid online in accordance with OGFR guidelines.	As per Odisha Preferential Procurement Policy 2024, the following relaxations shall be made for MSMEs, Pg 6-7 Exclusions Clause D, (ii) In Open Tender OSMEs taking part in open tender processes shall be exempted from the requirement of depositing cost of Tender Paper and EMD. Annual turnover criteria shall be relaxed in favour of OSMEs by 90%. For example, if Annual turnover criteria is Rs.10 Lakhs for non-OSMEs, it will be Rs.1 Lakh for OSMEs. They shall be fully exempted from past work experience criteria, if any. Performance Security, if any, shall be collected from them at concessional rate, i.e. @ 25% of what is applicable to non-OSMEs. <u>Hence, while EMD is exempted for all MSMEs upon production of MSME/NSIC certificate in the service sector, the terms and conditions regarding deposit of Performance Security is capped at 25% of original cost.</u> (The above clause will now form a part of RFP)
3	Is there any toolkit for Branding & Promotion for drafting creatives such as Banner & Standee for the capacity building workshops?	Yes, the RAMP Scheme guidelines for Branding and Promotion activities are to be strictly adhered to at all times including drafting the content for Banner and Standee for capacity building workshops.
4	What is the role of vendor in mobilization of participants for capacity building workshops at district level?	The mobilization of participants will be done at GM DIC level. However according to the scope of work in the RFP, C.
